The Reserve Bank of India (RBI) vide Circular No. RBI/2021-22/25/Ref.No.DoS. CO.ARG/SEC.01/08.91.001/2021-22 dated 27 April 2021, issued Guidelines for Appointment of Statutory Central Auditors (SCAs)/Statutory Auditors (SAs) of Commercial Banks (excluding RRBs), UCBs and NBFCs (including HFCs) (the "RBI Guidelines).

In view of the same, we wish to inform you that the Board of Directors of the Company at its meeting held on 25<sup>th</sup> September 2021:

- Took note of the letter dated 24<sup>th</sup> September 2021, received from M/s. Walker Chandiok & Co LLP, Chartered Accountants (Firm's Reg No:001076N/N500013) communicating their intention to resign from the office of Statutory Auditors of the Company effective from 25<sup>th</sup> September 2021, for the financial year ending 31<sup>st</sup> March 2022, being ineligible to continue as auditors of the Company after completing period of three years, in view of the said RBI Guidelines. Copy of the letter intimating their resignation is enclosed as Annexure-A.
- The Audit & Risk Management Committee and Board of the Company noted that the exiting Statutory Auditors have not raised any concern or issue and there is no reason other than as mentioned in their attached letter. Further, Audit Committee and Board at their respective meetings placed on record their appreciation for M/s. Walker Chandiok & Co LLP, Chartered Accountants as statutory auditors of the Company.
- Recommended for approval of Members in the ensuing AGM, the appointment of M/s. Manohar Chowdhry & Associates, Chartered Accountants (FRN 001997S) as the Statutory Auditors of the Company.
